



POSITION ANNOUNCEMENT:

The Office of Councilmember Eunisses Hernandez is seeking a thoughtful, hard-working, and compassionate team member to work in a collaborative, fast-paced environment as a **Planning and Land Use Deputy**.

The Planning and Land Use Deputy will handle a portfolio of entitlement casework, policy work and manage a variety of community planning and improvement projects. Working alongside the Planning Director, the Planning Deputy will assist in the ideation and implementation of land-use policy positions centered in undoing the impact of racial and economic disparities created by redlining, exclusionary zoning and systemic disinvestment in Council District 1 communities. Some evening and weekend work will be required.

The ideal candidate should demonstrate a commitment to racial and economic justice, possess strong knowledge and experience navigating the City of Los Angeles' planning and entitlement process; excellent organizational, communication and community-relations skills; the experience and sensitivity needed to work effectively with multiple-publics; and an ability to work well as a member of a team in a fast-paced, political environment.

Duties include, but are not limited to:

- Work in close coordination with the Department of City Planning, LADOT, LADBS and other City departments as necessary to achieve positive land use and transportation outcomes in the district;
- Navigate casework by utilizing a strong understanding of the relevant planning rules and regulations, including the various specific plans that apply in Council District 1;
- Understand environmental clearance and processing requirements, and identify additional or required mitigation measures and improvements to projects to reduce environmental impacts;
- Attend and speaking at planning hearings and community meetings, including those that occur during nights and weekends;
- Draft briefing papers, motions, letters and other project-related documents;
- Respond to constituents and keep open lines of communication with community stakeholders;
- Respond to and manage district level planning case work; and
- Other tasks as assigned by the Planning Director.





The ideal candidate should have experience in the following:

- 1-2 years of experience working at a municipal Development Services Center or in a project planning capacity;
- Previous experience in urban and transportation planning and implementation;
- Experience and/or an interest in transportation policy, environmental justice, climate and sustainability issues, regional and local planning issues, and safe street infrastructure;
- Excellent writing and communication skills;
- Demonstrated and utilized strong political judgment in high-stakes, politically sensitive projects or issues, in order to mitigate or avoid controversy and achieve success;
- Be self-directed and able to multitask:
- Have strong technological skills and proficiency in Google Docs;
- Proficiency in Spanish is strongly preferred but not required; and
- Must be a team player.

The position is full-time and exempt from Civil Service. **Yearly Salary Scale:** \$67,525.92 \$77,318.64. Compensation will be based on and commensurate with experience, and includes a high-quality benefits package; 13 paid holidays per year; flexible plans for multi-option health, dental, and vision coverage; and family and domestic partner leave.

In accordance with Los Angeles City Ordinance 187134, candidates must meet the minimum requirement of being fully vaccinated against COVID-19 or receive an exemption and report their vaccination status prior to being hired by the hiring City department.
